

User Agreement

1. General information

1.1 This User Agreement (hereinafter referred to as the Agreement) has been developed by the Administration of the website “Information Platform of the Leader Development Institute (Leader-ID)” <https://www.leader-id.ru> (hereinafter referred to as Leader-ID) and determines the conditions for use and development of Leader-ID.

1.2 This Agreement governs the relations between the Autonomous Non-commercial Organization “National Technological Initiative Platform” (hereinafter referred to as the Organization) and the natural person (hereinafter referred to as the User) registered at Leader-ID with respect to provision of the functions of Leader-ID personal cabinet, monitoring of the dynamics of the digital footprint left by the users of the University 2035 Platform and provision of opportunity to use the results of analytical tools of the National Technological Initiative ecosystem.

1.3 This Agreement is a legally binding contract between the User and the Organization, governing the conditions for placing by the User of Information about the User at Leader-ID and its further use.

1.4 Any disputes within this Agreement will be resolved in accordance with the applicable law.

1.5 This Agreement may be amended by the Administration of Leader-ID unilaterally without any special notification. Any amendments hereto come into effect from the moment of publication of the new version of the Agreement at Leader-ID.

2. Conditions for placing of Information about the User

2.1 The Organization offers the User to use the service for placing of Information about the User on the conditions included herein. This Agreement comes into effect from the moment of the User’s consent to the terms and conditions hereof in accordance with the procedure indicated herein.

2.2 The User must review the terms and conditions of this Agreement prior to the registration at Leader-ID.

2.3 The User shall provide accurate and complete Information about the User and keep it relevant. In case situations occur when the Organization has any doubts with respect to whether the User has provided accurate Information about the User and (or) whether the User is the holder of rights for the Information placed by such User, the Organization shall be entitled to delete the placed Information about the User or block access thereto at its own discretion.

2.4 Responsibility for unauthorized copying and use of Information about the User shall be borne by the persons and organizations illegally using the Information about the User published by Leader-ID.

2.5 Information about the User placed at Leader-ID shall not include the following information:

- violating the applicable law or third parties’ rights and interests protected by the law;
- insulting to morality, honour and dignity;
- malicious, threatening, slanderous, insulting, promoting hatred and/or discrimination of people based on race, ethnicity, sex or social status;
- promoting religious, racial or inter-ethnic discord;
- containing scenes including violence or cruel treatment of animals, pornographic materials and (or) materials containing child erotica, advertising of sexual services (including under the guise of other services), advertising of narcotic and psychotropic substances or information about the ways for their manufacture, purchase or use thereof, information about the ways for manufacture, purchase or use of explosives or any other weapons;
- which the User is not authorized to make available in accordance with the contract

- concluded;
- related to any patent, trademark, commercial secret, copyright, other rights for intellectual property objects, including third party author's rights and (or) related rights;
 - containing advertising or commercial offers, as well as spam;
 - containing computer codes intended for violation, destruction or limitation of functionality of any computer or telecommunication equipment, or programs used for unauthorized access, as well as serial numbers for commercial software products, logins, passwords and other means for unauthorized access to fee-based resources in the Internet;
 - containing other users' personal data;
 - containing unreliable data: impersonating other individuals or representatives of an organization and/or community without the rights to do so.

2.6 The Organization is entitled to refuse to place the Information about the User (block the User), as well as to delete (at its own discretion) any materials and information, provided that their content is inconsistent with the requirements of this Agreement and applicable law. In such a case, the Organization is not required to inform the User about the reasons for such refusal or deletion.

2.7 The User consents to bear responsibility for the Information about the User placed at Leader-ID by the User. The Organization is not responsible for the content of the Information about the User, its consistency with the requirements of applicable law, copyright violations, unauthorized use of trademarks, commercial designations, etc., as well as for possible violations of third party rights in connection with placing of the Information about the User at Leader-ID and/or its use in accordance with the terms and conditions hereof. In case if any third-party claims are received in connection with the placement of the Information about the User Leader-ID and/or the use thereof, the User shall such claims independently and at its own expense.

3. Rules for processing of the Information about the User

3.1 Data processed with the purpose of provision of the functions of Leader-ID personal cabinet, monitoring of the dynamics of the digital footprint left by the users of the University 2035 Platform and provision of opportunity to use the results of analytical tools of the National Technological Initiative ecosystem, is processed on the basis of this Agreement. For certain purposes, the User may give its consent for processing of its personal data, as well as for processing of the personal data approved for distribution by the personal data subject, by marking the relevant box in the registration form or other Leader-ID forms intended for personal data collection.

3.2 The detailed information about the processing of the User's personal data with the purpose of provision of access to the unlimited amount of persons to the document determining its policy with respect to personal data processing, as well as to the implemented requirements to personal data protection, is included in the Personal Data Processing Policy which is an integral part hereof.

3.3 Leader-ID Administration may receive personal data from ANO "National Technological Initiative University 2035" located at: 121205, Moscow, territory of the Skolkovo Innovation Centre, 1 Nobel'ya str., building 3, office 4. Personal data processing is performed with the purpose of monitoring of the dynamics of the digital footprint left by the users of the University 2035 Platform and provision of opportunity to use the results of analytical tools of the National Technological Initiative ecosystem.

Such processing of personal data is performed after acceptance of terms and conditions of this Agreement and with the purpose of performance thereof (para. 5 of part 1 of Article 6 of the Federal Law No. 152-FZ "On personal data").

The digital footprint personal data are used by the Administrator of Leader-ID represented by the employees of the Administrator of Leader-ID, authorized to process personal data.

The source of personal data is the University 2035 Platform operated by ANO “National Technological Initiative University 2035”.

The personal data subject rights are consistent with the personal data subject rights indicated in para. 6 of the Leader-ID Personal Data Processing Policy which is an integral part hereof.

4. Rules of operation for Leader-ID Users

4.1 The Organization not only offers services to the Users but also requires that they comply with certain rules of operation. In connection therewith, the Organization expects the following from the Users:

- proactive work within the Organization’s projects;
- participation in the events organized by the Organization and its partners;
- the participant’s readiness to provide the necessary information;
- readiness to respond to the Organization’s proposals with respect to performance of its task;
- proper conduct with respect to other participants of the Organization;
- use of resources offered by the Organization for their intended purpose.

4.2 The Organization reserves the right to exclude Users (delete User profiles at Leader-ID) in case of violation of the rules of operation, as well as in case of improper conduct by the User.

5. Grounds for exclusion if the User

5.1 User profile may be deleted in the following cases:

- distribution of information defaming the Organization, Leader-ID or other participants, regardless of the place and place of its occurrence;
- provision of information known to be false in the User profile;
- using Leader-ID for distribution of information inconsistent with the Leader-ID objectives and tasks (see About the project, For participants);
- lack of activity (participation in events, profile updating, competency updating, staying at Leader-ID) for more than six months;
- refusal to provide the necessary information to the Administration of Leader-ID upon request;
- repeated (more than three times) refusal to participate in the events initiated by the Organization and including participation of all informed User (e.g. surveys).

5.2 In case of existence of one of the grounds for exclusion of the User:

- The Administration of Leader-ID verifies the User-provided information for accuracy;
- in case of ambiguous interpretation of information, the Administration of Leader-ID sends a request to the User suspected of unacceptable actions;
- in case if the User’s action were not intentional but caused by an error, the Administration of Leader-ID:
 - gives a warning to the User (giving two or more warnings constitutes a ground for deletion of the User profile);
 - sends a request for elimination of the consequences for the violation to the User (failure to comply with such request constitutes a ground for deletion of the User profile);
- in case of any malicious actions by the User, the User profile shall be deleted by the Administration of Leader-ID.

5.3 In case of deletion of the User profile:

- the User profile may not be restored;
- The User excluded from Leader-ID is not entitled to create a new User profile;
- in case of detection of a new User profile, the Administration of Leader-ID shall delete such profile without warning.
